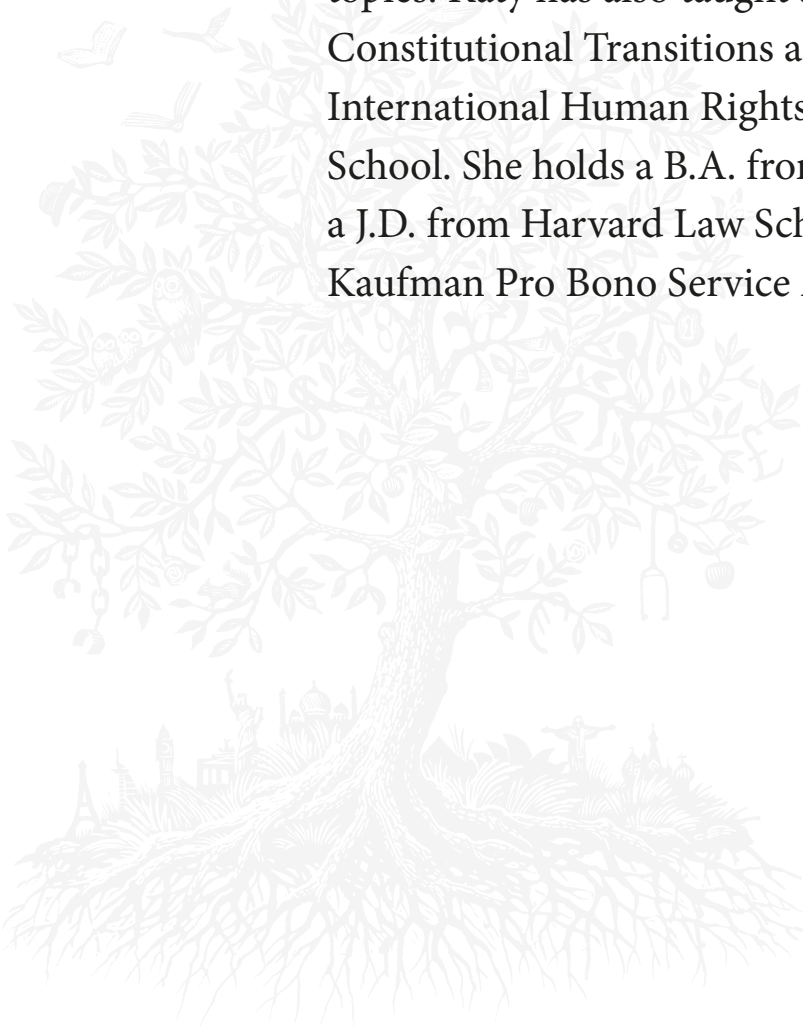


## Katy G. Bass

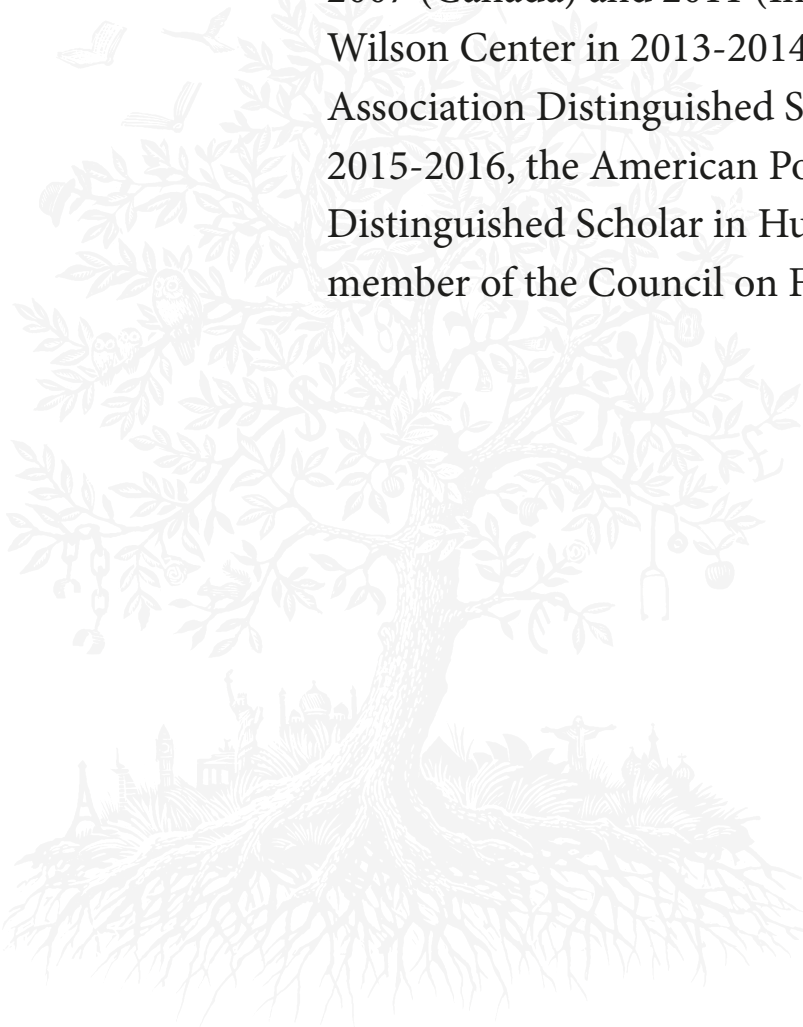


## Alison Brysk

Alison Brysk is the Duncan and Suzanne Mellichamp Professor of Global Governance at the University of California, Santa Barbara. She is the author or editor of fourteen books on human rights, including *Speaking Rights to Power, From Tribal Village to Global Village*, *Human Rights and Private Wrongs*, and most recently *Contesting Violence Against Women* (Oxford University Press). Professor Brysk was selected a Fulbright Professor in 2007 (Canada) and 2011 (India), a Fellow at the Woodrow Wilson Center in 2013-2014, the International Studies Association Distinguished Scholar in Human Rights 2015-2016, the American Political Science Association Distinguished Scholar in Human Rights in 2017, and a member of the Council on Foreign Relations in 2018.

Since 1984 he has directed the Political Terror Scale, which is the most widely used human rights data set in the world.

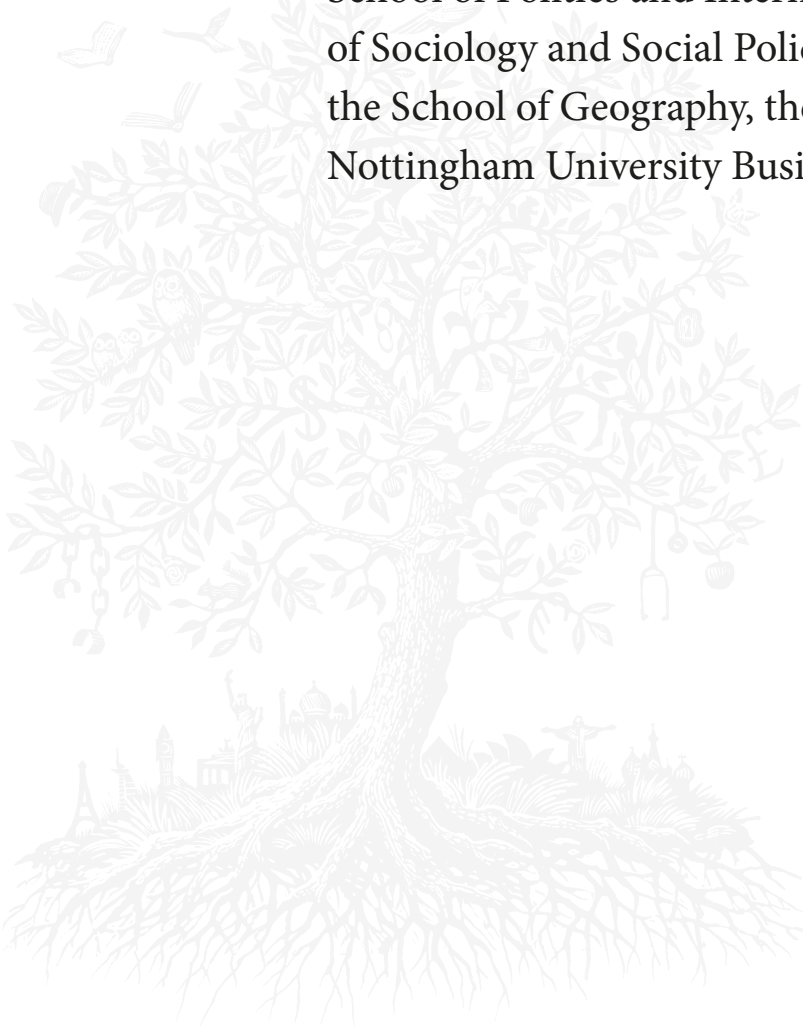


## Todd Landman

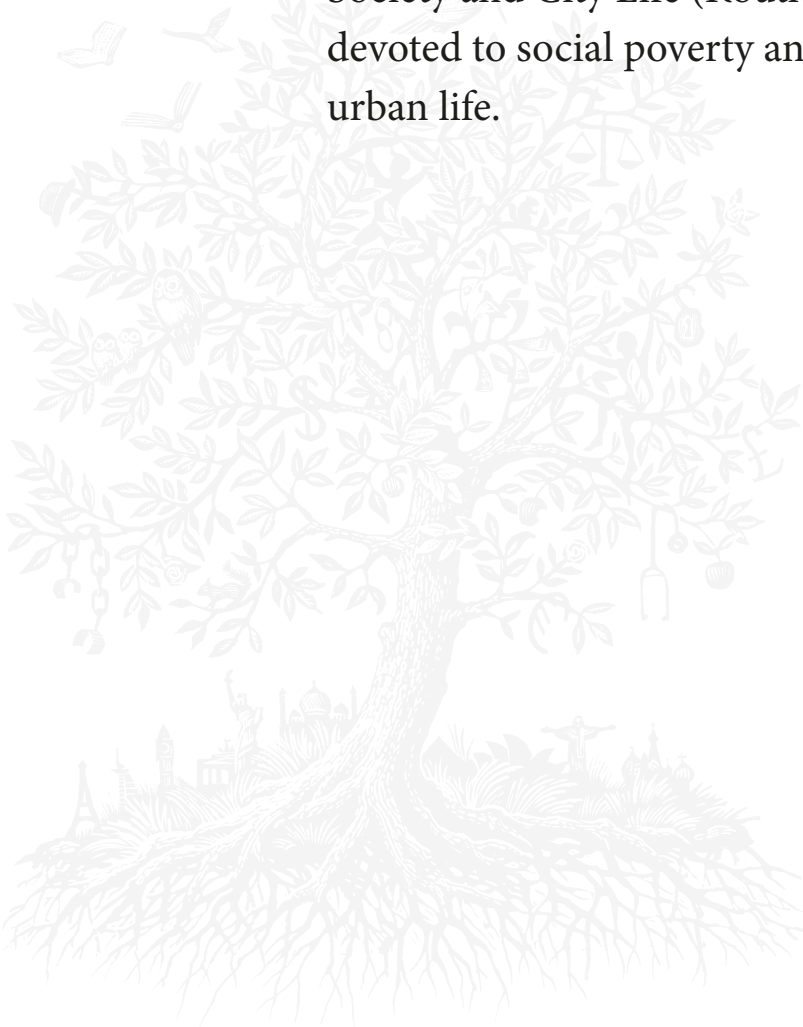


## Joseph D. Lewandowski

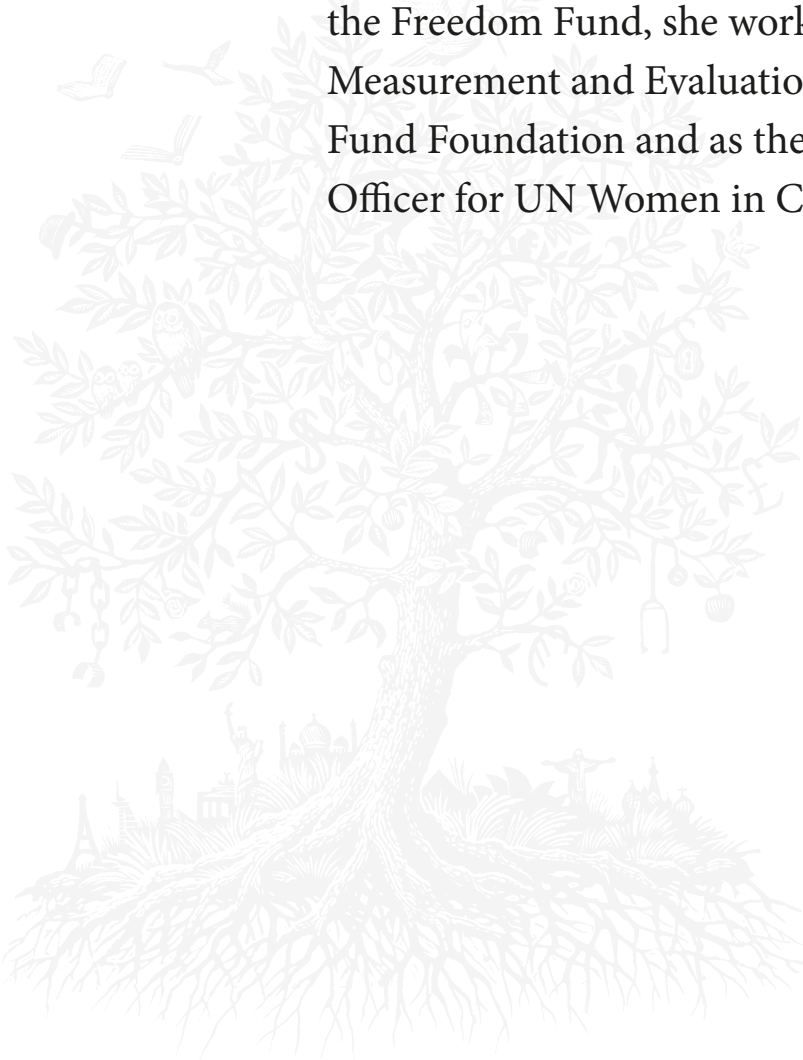


## Yuki Lo

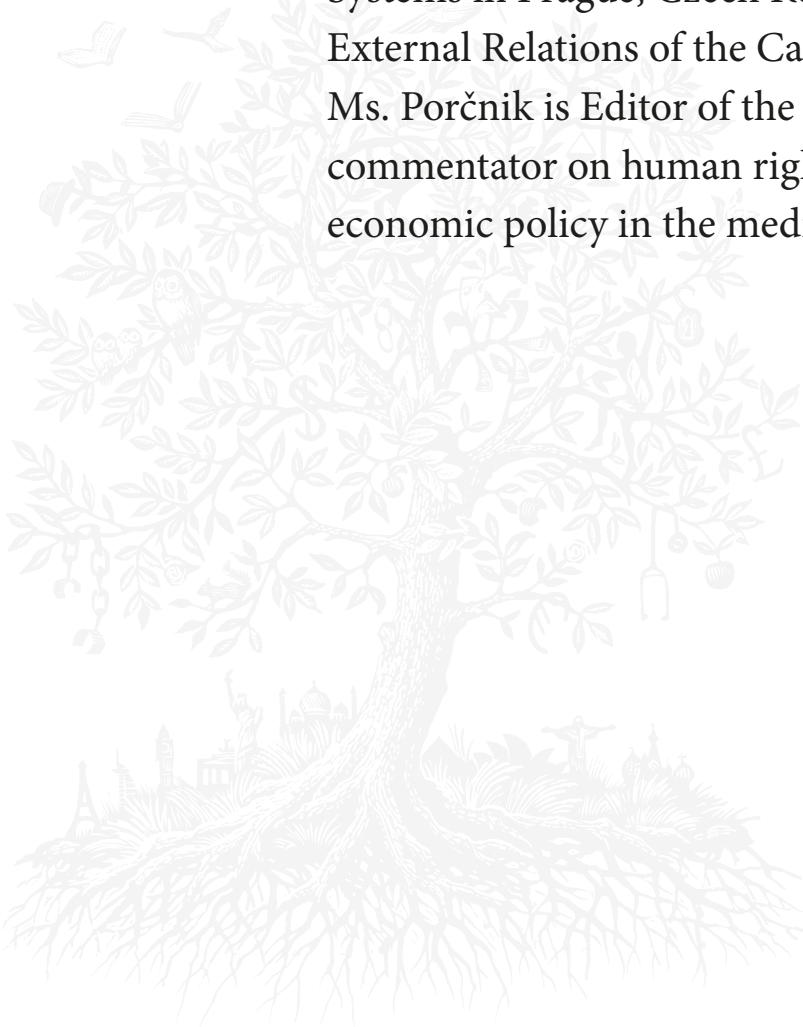


## Tanja Porčnik

He is the leading investigator of the Oxford Policy Dialogue, Co-PI of After Exit: Withdrawal of UN Peace Operations (ESRC), and Co-PI of Military Cultures and Peace Operations (Swedish Research Fund). Previously, he was Assistant Professor of International Relations at the University of Amsterdam. He holds a PhD in Government from the University of Essex (2011). His current research deals with civil wars and peacekeeping. His broader research interests include collective political violence, state development, and comparative politics.

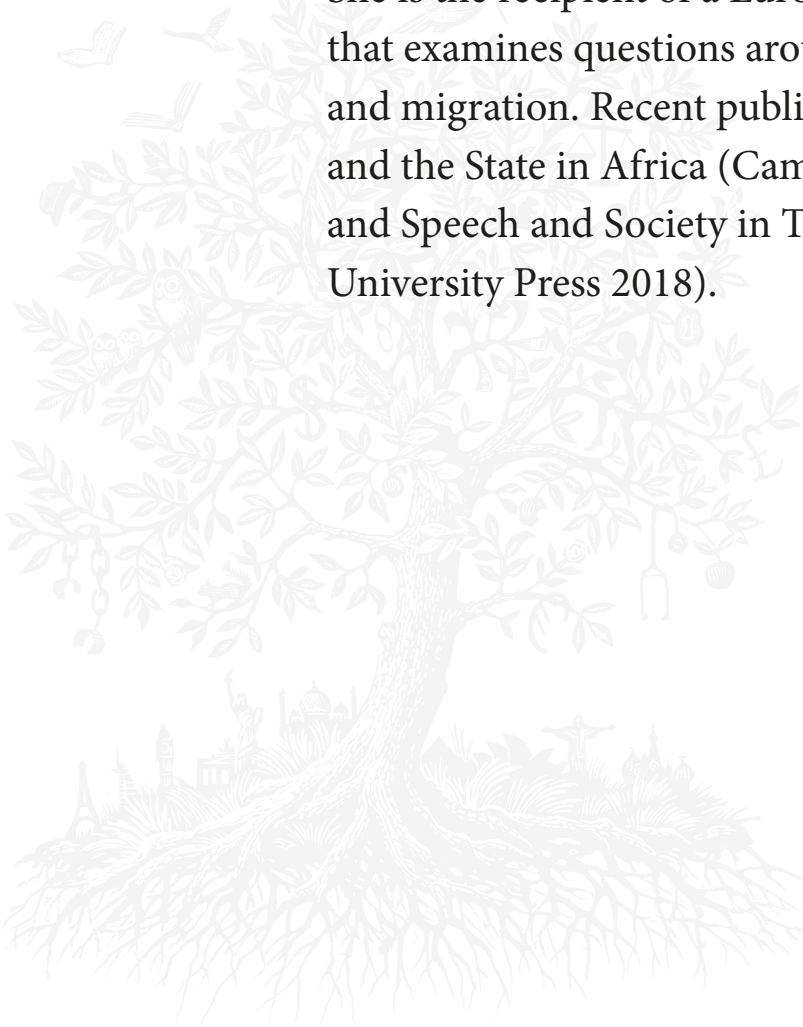


## Nicole Stremlau

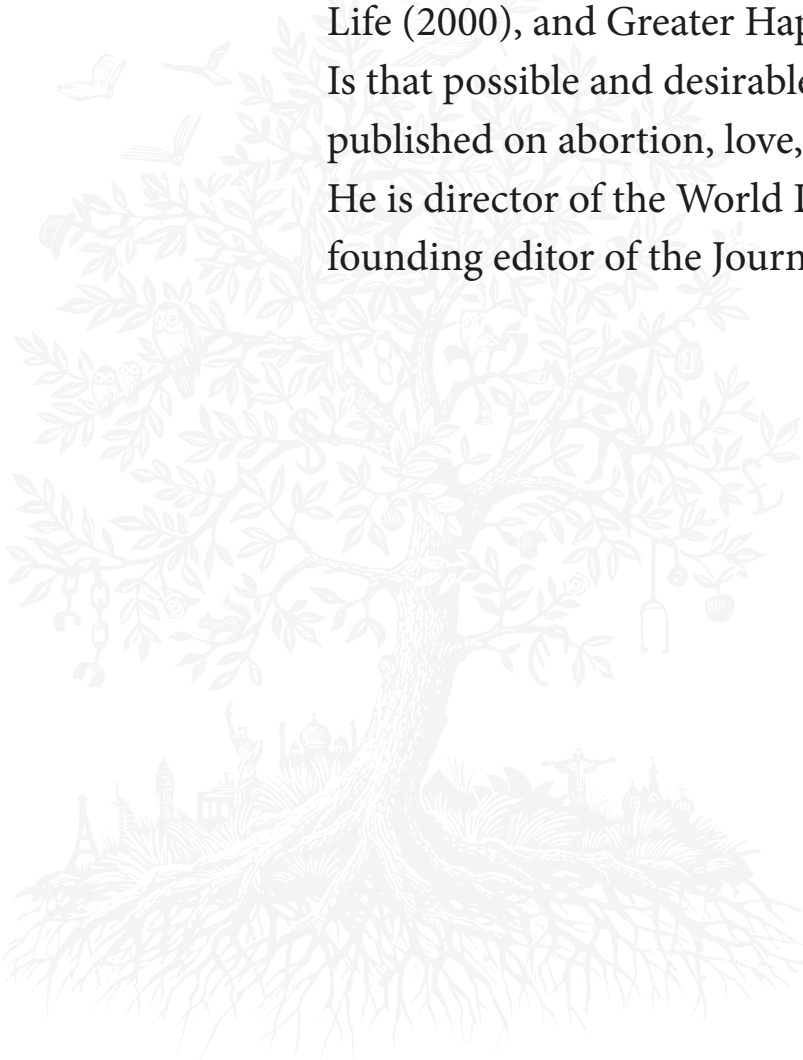


## Ruut Veenhoven

Director, World Database of Happiness

---

Ruut Veenhoven studied sociology and is also accredited in social psychology and social-sexuology. He is emeritus-professor of Social Conditions for Human Happiness at Erasmus University Rotterdam in the Netherlands and extraordinary professor at North-West University in South Africa. Veenhoven's current research is on subjective quality of life. His major publications are *Conditions of Happiness* (1984), *Happiness in Nations* (1993), *The Four Qualities of Life* (2000), and *Greater Happiness for a Greater Number: Is that possible and desirable?* (2010). Veenhoven has also published on abortion, love, marriage, and parenthood. He is director of the World Database of Happiness and a founding editor of the *Journal of Happiness Studies*.





## Charles Watters

Professor of Wellbeing and Social Care, University of Sussex

---

Charles Watters is an expert in the field of migration and specifically the impact of migration and displacement on wellbeing. His current research projects focus on the wellbeing and integration of refugee and migrant children in schools across Europe, on the wellbeing of migrants and refugees in urban areas including cities in Europe and India, and on the impact of coastal erosion on vulnerable populations. He is also currently chairing an academic forum on migrants' aspirations.





## Scott Winship

Executive Director,  
United States Congress Joint Economic Committee

Scott Winship is the executive director of the Joint Economic Committee (JEC) of the US Congress. There he directs the Social Capital Project for JEC Chairman Mike Lee. Prior to joining the JEC, Scott conducted research on living standards, poverty, inequality, unemployment, and economic mobility at the Manhattan Institute, where he was the Walter B. Wriston Fellow, and at the Brookings Institution, where he was a fellow. Earlier in his career he was the research manager of the Pew Economic Mobility Project and a senior policy advisor at Third Way. Scott received a Ph.D. in social policy from Harvard University, where he was a National Science Foundation Graduate Research Fellow and a Fellow in the Multidisciplinary Program on Inequality and Social Policy.
